Dear Residents,

As you may be aware from our previous letters, we are working along the footpath between the edge of the Lisvane reservoir and Black Oak Road, as part of our project in Lisvane and Llanishen Reservoirs.

Unfortunately, the existing valve chamber is in a worse state of repair than we expected, so the work is taking longer than planned. This means we need to extend the closure on the stretch of footpath running behind Rhyd-y-Blewyn Farm and 117 Black Oak Road.

We now plan to reopen the footpath by Christmas.

A temporary alternative route along Black Oak Road will be in place while we work and will be signposted locally.

We're sorry for the ongoing inconvenience and would like to thank you for bearing with us while we carry out this important work.
